Biographical Information Overview of Interview: Linda Chapa LaVia was born on August 16th, 1966 in Aurora, Illinois. She is a graduate of East Aurora High School in 1984 and attended Northern Illinois University, where she also participated in ROTC. Upon graduation from the University of Illinois Chicago in 1991, she was commissioned a second lieutenant, serving in the U.S. Army and later, the Illinois Army National Guard. She has been a self- employed real estate broker with her mother's real Estate Agency, Chapa Real Estate. In 2002 Chapa LaVia was elected to the Illinois House of Representatives. Representative Chapa LaVia (D-Aurora) serves the 83rd District. She is the first woman legislator to have served on active duty. In the General Assembly, she serves on several committees, including Education (chair), Veteran's Affairs and Telecommunications (see details on General Assembly home page). She has served eight years a legislator.

Chapa LaVia discussed school consolidation issues and, specifically, Illinois House Bill 1216 (2012), which would create the School District Realignment and Consolidation Commission. She also addressed current ways that schools can reorganize and state incentives regarding such reorganizations. The objective of the commission would be to examine the appropriate number of school districts, their optimal enrollment and locations where reorganization would be helpful.
